1. Decision

To agree the statutory proposal to change the age range of Widford School, Ware Road, Widford, Hertfordshire, SG12 8RE, ("the School") a community school, by changing the age range from 4 to 11 years to 2 to 11 years from 8th January 2018, taking into consideration the outcome of the statutory notice period.

2. Reasons for the decision

At the Hertfordshire County Council Cabinet meeting of 13th November 2017, Cabinet authorised the Director of Children's Services to publish a statutory notice to change the age range of Widford School from 4 to 11 years to 2 to 11 years, to enable the school to offer nursery provision to children from the age of 2 from 8th January 2018.

The statutory notice period ended on 21st December 2017 and no objections to the proposal were received. It is now for the Director of Children's Services, under the terms of the delegated powers invested in her, to approve the proposal.
