1. Decision

To commence on 23 January 2018 for a period of 7 weeks the consultation on the proposal to permanently enlarge the premises of De Havilland Primary School, Travellers Lane, Hatfield, Herts, AL10 8TQ by 30 places (1 form of entry) from September 2019, conditional upon the granting of town planning permission for the building scheme.

2. Reasons for the decision

The Director of Children's Services, under the terms of the delegated powers invested in her, decided to commence the consultation on the proposal to allow the permanent enlargement of the school premises on its existing site to accommodate an increase in the size of this school by 1 form of entry to 3 forms of entry to ensure that sufficient places are available. The current capacity of the school is 420 and the proposed capacity will be 630 pupils (excluding Nursery pupils.
