1. Decision

- 1.1 That the Head of SEND Commissioning has determined that Annex A to this Decision Record should not be disclosed to the public as it contains exempt information as defined by Section 100 of the Local Government Act 1972, Schedule 12A, the public interest in maintaining the exemption outweighing the public interest in disclosing that information;
- 1.2 Subject to 1.1 above, awards the contract for the Provision of Integrated Therapies to the preferred supplier set out in Annex A and approves the signing of the contract.

2. Reasons for the decision

A procurement process has been carried out to award a contract for the Provision of Integrated Therapies based on the most economically advantageous tender when evaluated against the following criteria:

Price 40% Quality 60%

The Council issued an Invitation to Tender following a Contract Notice being placed in the OJEU on 13th February 2019. Following a number of clarifications raised by bidders, and addressed by the Council, one tender was submitted by the deadline of Friday 27th March 2019.

The tender bid was evaluated against a pre-disclosed robust set of evaluation criteria.

The name of the successful tenderer is set out in Annex A.
