1. Decision

To deploy the HCC allocation of the Adult Social Care Discharge Scheme totalling £3.445m provide bonusses, shift enhancement and retention payments for care workers in Herts during the winter period.

To authorise the Executive Director of Adult Care Services to make any further decisions to support the recruitment and retention of care workers over the winter period, in consultation with the Executive Member for Adult Care, Health and Wellbeing, the Executive Member for Resources & Performance and the Director of Finance.

2. Reasons for the decision

On the 18 November 2022, the Minister for Health and Social Care announced terms of the national Adult Social Care (ASC) Discharge Fund to bolster social care workforce and increase capacity for packages of care to support more discharges from hospital.

A key element of the picture is the pressure on the social care workforce. Skills 4 Care's 2021/22 Care Workforce Data for Hertfordshire indicates overall turnover in the care sector workforce of 30.3 % (2020/21: 27.9%). Overall vacancies for the sector in Hertfordshire were reported at 11% compared with 8.8% for 2020/21.

The County Council is expecting to deal with challenging conditions as demand pressures continue over the winter period. The County Council is directing its share of the ASC Discharge Fund to support the care work force over this challenging winter period to ensure its resilience and continuity over this time in support of Hertfordshire residents and the wider health and care sector in the county.

3. Alternative options considered and rejected

A number of other options for supporting discharges from hospital are being delivered through the ICB controlled allocation of the Adult Social Care Discharge Grant. Should further need arise to take action to support recruitment and retention over the winter period it is proposed that the Executive Director of Adult Care Services is empowered to make any such decisions, in consultation with the Executive Member for Adult Care, Health and Wellbeing, the Executive Member for Resources & Performance and the Director of Finance.
