2. Reasons for the decision

These enlargements schemes will provide much needed local places for our most vulnerable children. In doing so they will reduce the impact on the High Needs and School Transport revenue budgets, as the number of children being placed out of county will reduce, as need can be met locally.

3. Alternative options considered and rejected

Despite the work to explore alternative options, including additional support in mainstream settings and out county placements, a number of children with SEND are still without an appropriate school place for September 2022. Further analysis of the level and need of these remaining children has informed a review of the limited enlargement opportunities remaining across our special schools.

This review concluded that the enlargement proposals listed in section 1 best meet the immediate need for places.
